Acceptance of the Terms of Use

Welcome to the website of Roam Your Home (the “Company”, “we” or “us”). The following terms and conditions (together with any documents referred to in them) (the “Terms of Use”) apply to your use of www.roamyourhome.com , including any content, functionality and services offered on or through (the “Website”), whether as a guest or a registered member.
